## Bar Bulletin Cover Art Submission Requirements

The State Bar of New Mexico's official publication, the *Bar Bulletin*, is a professional journal published weekly for the legal community of New Mexico. We invite artists to submit their artwork to be displayed on the cover. The *Bar Bulletin* is distributed hard-copy and electronically to more than 8,000 attorneys, judges, and other members of the legal community each week! We hope you will consider submitting artwork.

#### **Submission Requirements**

- Only digital artwork files (jpeg or tif) can be accepted. We cannot scan materials. Files can be submitted by email or file-sharing services (i.e. GoodleDrive, DropBox). Files cannot be downloaded from websites.
- Files should be a minimum of 300 dpi. Photos will be cropped mindfully to one of the dimensions below. If you would prefer to control the cropping of your artwork, please ensure it meets the requested dimensions before submission.
  - o Vertical: 4.125 inches (width) by 5.5 inches (height)
  - o Horizontal: 6.75 inches (width) by 4.125 inches (height)
- Due to the wide audience and professional nature of the *Bar Bulletin*, religious themes, nudity, or vulgarity cannot be accepted. In the past we have featured everything from photography, oils, watercolors, to digital art, sculpture and jewelry work, and more!
- All artwork should be professionally photographed against a neutral background. However, ceramics, models, jewelry, and other standing art must be submitted at a particularly high quality.
- If you have submitted artwork in the past, please do not re-submit the same material. For a list of artwork you've submitted in the past, contact us.

### To be considered, each artist must submit the following:

- Completed Artist Release Form
- Completed Artist Information Sheet
- Digital artwork files with titles (we recommend artists submit 3 to 5 pieces of artwork)
